






Year after year, Italy keeps remaining in the **lower part** of the ILGA-Europe chart. While Brussels has recently voted to include abortion among the fundamental rights of the EU and France has included abortion in its constitution, in Italy **law 194** (on the right to termination of pregnancy) is repeatedly under attack by national and regional politics.

In Italy, the senate Justice Commission has just given the green light to the bill that will make surrogacy a universal crime.










# WHY IS EUROPRIDE SO IMPORTANT FOR ITALY?

# THE SITUATION FOR RAINBOW FAMILIES



All over Italy we are witnessing a gradual **demolitión** of every effort to safeguard the **rights of children** of LGBTQIA+ parents.

Italy is the only EU founding member state (and the only country in Western Europe) to **neither recognise equal marriage**, the right to **adoption** for same-sex couples (or single parents), nor allow recognition of a child at birth for same-sex parents.

So far, all we have is the inadequate law on civil unions (2016) that does **NOT** include any children's rights or the right to adoption. These children are denied their right to inheritance, to health, to education.


> NOT EVEN CHILDREN BORN THROUGH SURROGACY ABROAD ARE REGISTERED, THUS DENYING THEM ITALIAN CITIZENSHIP (THEY ARE FOREIGNERS IN THEIR OWN COUNTRY!).

A new bill [...] wants to criminalise surrogacy with fines up to one million euro and penalties up to two years in prison. The Lega party has proposed an increase up to 2 million euros and 10 years.

THE SITUATION FOR TRANS\* PEOPLE


It is estimated that trans<sup>\*</sup> people in Italy are between 1% and 4 % of the adult population today. This means that about 500,000 people are covered by a law (no. 164, regulating gender) affirmation pathways) from **1982**, thus **very old, outdated** and lacking in many ways.

The pathways are very long and complex, highly medicalized and, meanwhile, people are living with **misaligned documents**, facing great difficulties at school, and accessing work, the right to vote and the right to healthcare.

Access to pathways in public health is **increasingly difficult**, and private costs are extremely high.

> THE GOVERNMENT IS TRYING TO PREVENT TRANSITION FOR HOSPITALS AND HAS SET UP AN EXPERT GROUP TO QUESTION THE PATHWAY FOR ADULTS AS WELL.

For example, the possibility of alias career is not a right established by law but it is left to the discretion of schools or workplaces

# LACKING EQUALITY MARRIAGE


Through a long and **bumpy path**, in 2016 civil unions were eventually approved in Italy. Since then, egalitarian marriage has disappeared from the political agenda because institutions believe that the LGBTQIA+ community has no right to demand anything more than civil unions.

Italian civil unions are second-class marriages, in other words: discrimination.

> AS AN EXAMPLE, THE NON-BIOLOGICAL PARENT CANNOT ADO PARTNER'S CHILD

In 2002, Franco Grillini presented the bill on PACS, (Civil Covenants of Solidarity). but the Berlusconi government stalled the issue. In 2007, the then-Family Minister Rosy Bindi's proposal on **DICOS**, (Rights and Duties of Permanently Cohabiting Persons), which would provide for the recognition of new rights for unmarried heterosexual and homosexual couples, also foundered.






Meloni's Government has invested in increasing the number of Permanence and Repatriation Centres and the **duration of stay** (inside them) of migrants arriving in Italy.

In particular, **requesting international protection** for individuals persecuted in their home countries because of their gender identity or sexual orientation will become more difficult.


In 2023, the Lega Party proposed to reform the Consolidated Law On Immigration to **cut out sexual** orientation and gender identity as reasons to request special protection.



IT IS NOW ESTABLISHED, BY ALL NGOS THAT THIS IS A FORM OF IMPRISONMENT NOT HAVING COMMITTED ANY CRIME, THIS DETENTION IS COMPLETELY UNACCEPTABLE.

For example, since - the full-scale Russian invasion of Ukraine, many LGBTQIA+ refugees have arrived in Italy and have been supported by our associations. When governments are lacking we are always there!







In Italy, anti-gender movements such as *Pro Vita & Famiglia*, derived from the French *Manif pour Tous*, have gained strong legitimacy with the establishment of the far-right government.



This would be the first time in Italy that an international-level Pride has not been held in the capital city.

Pride is the event that, more than any other, includes and represents everyone. Individuality gives way to sharing.

Precisely for this reason, the **decision** to candidate Torino for EuroPride 2027 has been enthusiastically welcomed by Italian Prides who have pledged to collaborate and support the candidacy.

The Pride coordinations of Alessandria, Asti, Caserta, Catania, Liguria, Milano, Napoli, Pavia, Reggio Emilia, Roma, Salento, Sardegna, Umbria, Varese, Vesuvio

stand alongside Torino.







# Some SITUATIONS IN TORINO ARE DEFINITELY CONVENIENT (to host EuroPride)

Torino would be a good place to host EuroPride for many reasons, but it is first and foremost for political ones: the Piedmont Region (right-wing government) and the City of Torino (left-wing government) have both decided to support the bid together.

Also thanks to the daily political work done by Coordinamento Torino Pride, our city is used to putting **rights in the spotlight**.



We have managed to build a very important institutional network over the years (as you can see from the number of letters of support).
















# WE ACTUALLY (and are proud of it)



In 2018, the Mayor of Torino **registered the birth certificates** of children of three same-sex couples at the civil registry office. This is the first time in Italy that a mayor has made this choice (and taken the risk) without a court order.



In 2019, **ToHousing opened in Torino**. It is a social co-housing specifically dedicated to LGBTQIA+ people in need and extremely vulnerable. So far, it is the largest of its kind in Italy.



In order to meet some of the needs of the LGBTQIA+ population, **CasArcobaleno** was founded in Torino in 2014.

In 2022 Torino hosted EPOA's 29th AGM, attended by 170 delegates from across Europe and North Africa.

In 2011 Torino hosted ILGA Europe's 15<sup>th</sup> **Annual Conference**, attended by 250 delegates.

The City halted regist in March 2022 as Mayo Stefano Lo Russo received pressure from the national government.




We are very **proud of the network** we have managed to build over the years, which is underlined by **the support we** have received since our candidacy to host EuroPride 2027 became known.



At present, the City of Torino has set aside € 150,000 and the Regional Government is working to allocate  $\in$  250,000. In addition, a large national sponsor such as IREN has already approved of  $\in$  50,000 contribution. So far, the total amounts to € 450,000.

Beyond classic scholarships: it also contains funds for people from the Mediterranean Area and Middle East Countries.

The long-term collaboration with Lovers Film Festival gives us the chance to plan events like a film exhibition about the history of LGBTQIA+ movements in Europe.




Torino Pride relies on many volunteers, and our primary goal will be to engage **bilingual** people and schedule English classes for others, that can make them available to support all activities.

The **marketing plan** will be prepared in 2025, to be operational from the beginning of 2026. It will include:

- # a bilingual website that will gather all the information about the progress of EuroPride 2027 promotional activities
- # a mobile app with real-time info
- # social management activities involving influencers
- # PR missions at various European events in 2025 and 2026 (such as Lisbon EuroPride, Amsterdam WorldPride)
- # participation to Prides in Italy and Europe
- # local, national and international press office
- # strategic partnerships with tourism promotion companies that will facilitate participation to the main European tourism fairs in 2025-2027







The EuroPride week would be in June 2027 between Friday 18<sup>th</sup>, when the Opening Ceremony would take place, and **Saturday 26<sup>th</sup>**, with the EuroPride March and the Closing Ceremony.

All the events would be totally safe and free of charge. Our undivided attention would be on welcoming young people and those with access needs in some way. All events would be accessible and inclusive: as we always do, we would take every measure to get rid of barriers.

Should Torino host EuroPride 2027, we have already arranged with other Italian Prides that no other march would be overlapping




# LGBTQIA+ MIGRATIONS

# SPORTS: ISSUE OR RESOURCE?

During the Paris Olympics we once again witnessed how problematic sport and its rules can be, especially for Trans or non-binary people. On the other hand, it is an extraordinary chance to bring visibility and inclusion to the entire community. We would open the debate with experts and athletes, involving the most important sports federations.







Hoping that in 2027 the world will be on a path to global peace, in this focus we would address the different positions but mainly the **effects** that armed conflicts have always had **on LGBTQIA+ people** in every part of the world.

# HEALTHCARE AND LGBTQIA+ PEOPLE

It is now scientifically established how discriminatory practices and a queerphobic environment affect the health of LGBTQIA+ people on various levels. We would address the causes and effects that lead our community to have **mental health** problems, often unrecognised, and difficulties in accessing health systems due to shame or rejection. The differences between European healthcare systems cannot keep being an obstacle or generate forced migrations in search of a welcoming environment.

MORE ABOUT INCLUSIVE HEALTHCARE



If the **minority stress model** is showing us the effects of discrimination and stigma on LGBTQIA+ people and it's warning us about the **risks of exclusion** and marginalization, new research studies study are investigating the exciting potential of the so-called minority joy; the focus wants to explore this inspiring new perspective and discuss how positive identity-related factors can help LGBTQIA+ people finding joy, resilience and social support.










THE PICTORESQUE BONFIRE AND THE HISTORICAL REENACTMENT ARE SOME OF THEM

The goal is to provide participants with useful tools to act and interact without homotransphobia. Every year a student section of Treno della Memoria takes part in the Pride March with their truck.

# MARCH 2027 STAR.T

The event was created with the aim of giving visibility to the achievements of trans\* people and it takes place on Transgender Day of Visibility.

At the event, awards are given to trans\* people who, through their personal experience, work or activism, have made a valuable contribution to the visibility of the trans\* community.

The great press coverage that the Festival has would definitely be a plus.










Torino is a city that has seen many changes over a short period of time. Today queer nightlife and LGBTQIA+ **events have multiplied** under the banner of inclusiveness.

Dear Board of Europride, it is with great pleasure that Antinoo Arcigay Napoli supports and en-dorses Torino Pride's candidacy to host EuroPride 2027. Turin has assumed great importance for Italian LGBT+ culture since the 1970s: in Turin, in fact, in 1971, the activist and bookseller Angelo Pezzana, together with other militants, founded the F.U.O.R.I. (Ita-lian Revolutionary Homosexual Unitary Front), the first large Italian gay association. It is important to remember that the association also published a magazine of the same name with which very important LGBT+ intellectuals, such as Mario Mieli, Mariasilvia Spolato and Alfredo Cohen, collaborated. In 1976, the gay activist Felix Cossolo founded the magazine Lambda in Turin which became a reference newspaper for the Italian gay libera-tion movement until it closed in 1982.

The movement of gay believers also originated in Turin thanks to the activist Ferruccio Castellano and in the province of Turin, at the ecumenical center of Agape, the first national conference "Faith and homosexuality" was organized in 1980.

In more recent years, Turin has stood out for the cultural activities promoted by the Sandro Penna Foundation and the Fuori Foundation and above all for the LGBT+ Film Festival - Lovers Film Festival (born as Torino gay and Lesbian Film Festival) founded by Ottavio Mai and Gio-vanni Minerba in 1986 which is the oldest LGBT+ film festival in Eu-rope. In short, for many years Turin has become an important hub for the promotion of LGBT+ rights in Italy also thanks to the sensitivity de-monstrated by the city's municipal administration: for example, during the mayoralty of Chiara

# TORINO EUROPRIDE 2027 CANDIDATE CITY



## OVR SPONSORSHIPS ETHICAL POLICY

While appreciating essential support, resources and finances of corporate partners and sponsors, it is essential to maintain our independence and avoid partnerships that are not compatible with our values.

This document applies to all partners and sponsor collaborations of Coordinamento Torino Pride activities including, for example, financial support, participation in events with their own signs and logos, collaborations on individual events.

### **1. VALUES AND MISSION**

As an organization rooted in the culture of equality and human rights, our values run through everything we do and this includes our partnership and sponsorship agreements. We want to achieve the highest possible ethical standard when considering a potential partner or sponsor.

A genuine commitment to LGBTQIA+ equality cannot be viewed through a narrow lens that excludes other human rights, social justice and equality issues, and our ethical standard reflects our unwavering commitment to the broadest spectrum of equality and human rights causes, through an intersectional approach.

The entities that officially participate in our events, partners and sponsors do not influence the policy or operation of Torino Pride which remain independent. In consideration of our commitment to transparency, all partners and sponsors are listed on our website on the pages relating to the various initiatives.

### 2. GROUNDS FOR EXCLUSION

The organization will not accept support or collaboration with entities and companies whose commercial or other objectives conflict with our values and objectives, or that may promote inaccurate or misleading messages about our commitment to these objectives and values.

All partners will be subject to a reasonable due diligence process according to which the organization will seek to understand any potential risks of the partnership.

There are sectors that are intrinsically incompatible with a healthy and happy society and planet. Therefore, we will not enter into agreements with:

- A. Companies in the fossil fuel extraction sector or the transformation and sale of fossil fuels if they do not adopt, through sustainability governance, a mix of sustainable energy sources that demonstrate a concrete commitment to the ecological transition.
- B. Companies that manufacture or promote tobacco products.
- C. Companies that manufacture or sell weapons, except those made for recreational purposes (e.g. sport shooting) subject to controlled sales to prevent their purchase by individuals, regimes or organizations with violent and belligerent intent.
- D. Companies that promote alcohol in a way that does not comply with the standards established by current legislation in relation to consumption, advertising, marketing and underage sales.
- E. Companies that produce in countries where homosexuality and/or trans<sup>\*</sup> identity is illegal or persecuted, unless the company has a policy that provides support to LGBTQIA+ advocacy organizations in that country.
- F. Companies and entities that financially or in any other way support regimes or organizations that violate human rights.
- G. Entities that directly or indirectly violate the European Convention on Human Rights or the Universal Declaration of Human Rights.
- H. Companies and entities that directly or indirectly violate international treaties or standards recognized on environmental protection.
- Companies and entities that have implemented homo-lesbian-bi-trans-a-phobic, racist, xenophobic, ableist, fatphobic, misogynistic, sexist or, in general, discriminatory behavior towards any minority or marginalized subjects.

In addition to the sectors listed above, the organization has problems establishing collaborations with:

A. Companies with a proven poor track record on labor rights and environmental sustainability.

- B. Companies with a proven poor reputation with respect to ethical sponsorships and marketing actions such as, for example, greenwashing and pinkwashing.
- C. Companies with a proven poor reputation with respect to diversity management, equality and/or inclusion within their corporate culture.
- D. Companies and entities that adopt unethical business methods and practices at the expense of people and communities with a low socio-economic status.

The list in this document is not exhaustive and an assessment will be carried out on each potential sponsor or partner from time to time.

### **3. FINAL TERMS**

In addition to what was previously established, these final provisions are added.

- A. Under no circumstances will the organization promote corporate products or services. Visibility of the support received will always be made in accordance with the terms agreed upon time of the sponsorship agreement.
- B. The organisation will not accept from any corporate partner more than 10% of the current year's budget (or, if different, the year in which the funded initiative is scheduled to take place) so as not to risk compromising its integrity. This does not include money raised through employee and customer fundraising as part of any corporate partnership agreement.
- C. Corporate sponsorships with a value greater than  $\in 2,500$ must be approved internally by our board of directors.
- D. Contracts with partners must allow the organisation to withdraw from any partnership where new developments involve a breach of the provisions of this Partnership & sponsorship ethics policy.

This document will be updated, supplemented and amended whenever deemed necessary by the organisation.













## willy is ACCESSIBILITY SO IMPORTANT TO US?

**Torino Pride firmly** believes that prides should be accessible to anyone, no matter their physical, cognitive or personal abilities.

When the Zan bill, a proposed law to protect LGBTQIA+ people, women, and people with disabilities, was rejected in October 2021, a rupture occurred. Faced with the shocking sight of rightwing and far-right parliamentarians cheering wildly over the latest defeat of civil rights, the community united to stand against the rampant hatred. Intersectionality has become paramount, as those at the intersection of more than one marginalized identity often face multiple, interconnected **discriminations** that can exacerbate the negative effects on their lives and well-being.

For this reason, a **collaboration** has started between the Torino Pride and local associations focused on **accessibility** to work towards common objectives to ensure that no one is left behind.

Since 2022, Torino Pride has included a **sensory** decompression area within the parade for everyone that might need it. A quiet space marked by a dedicated banner with Pride volunteers providing support and guidance. We are aware that pride will never be silent, but we are committed to creating an inclusive space, so before the parade starts, we offer earplugs, mineral salts, and stim fidget toys. In 2024, training was held with the Mai Ultimi staff, a student collective that aims to educate on disability, SLD, SEN, ADHD, combat able-ism, and support the disabled community towards empowerment and rights awareness. The training aimed to prepare Pride volunteers assigned to the decompression space to ensure optimal management during the parade.

For those with **mobility issues**, a small bus is available at the head of the parade, following the en-

tire march to allow participation without leaving the event.

The **pride route** is always available on the website showing the presence of accessible bathrooms, sensory decompression points along the route, and rough roads or areas that may present difficulties for people with mobility impairments.

**Speeches** from the Pride stage are always available in text form a few minutes before they are delivered and a **sign language interpreter** translates them simultaneously.

The stage itself is accessible and has an uncongested area for those who need a quieter space.

In 2024, volunteers from Torino Pride and Disability Pride participated in a joint training session at CasArcobaleno. The Disability Pride Network (DPN) is an informal network of organizations and individuals which serves as a powerful amplifier for the voices of people with disabilities, their families, and their advocates engaged in the struggle for a world accessible to all.

This training allowed the sharing of knowledge and skills, improving the volunteer staff's ability to address inclusivity and accessibility needs. The collaboration between Torino Pride and Disability Pride Torino also took shape through active and mutual participation in our respective Prides.

Torino Pride wants to be a place where everybody feels welcome and safe; we believe intersectionality and accessibility to be crucial stepping stones to reach this goal.









## THE ALARMING SITUATION OF LGBTQIA+ MIGRANTS

All the associations in Torino Pride have been dealing for years with many requests from migrant people, and have saved many lives.

The human rights situation of LGBTQIA+ migrants continues to be alarming globally: 73 states have explicit laws criminalizing consensual sexual relations between adults of the same sex. To understand the magnitude of this number, just think that this figure corresponds to approximately a third of the countries in the world. This should also be added to the fact that in 13 countries belonging to the United Nations - equal to 6% - the death penalty is foreseen for those who have homosexual relations.

Within the European Union, the LGBTQIA+ community is still subject to hatred and violence and, even today, member states present conflicting and ambiguous attitudes regarding the recognition of the rights of LGBTQIA+ asylum seekers.

For its part, international law does not explicitly protect LGBTQIA+ migrant people with specific laws, nor does the Geneva Convention on the status of refugees of 1951 include them, but international jurisprudence, considering the Yogyakarta Principles of 2006, the European Charter of Rights fundamentals of 2000 and the UNHCR Guidelines of 2012, decided to include them in the name of the principle of non-discrimination. Italian jurisprudence did the same thing in a 2015 ruling.

Nonetheless, on 9 March 2023 the Italian Parliamentary Commission examined the proposal of the Northern League MP Igor lezzi to eliminate sexual orientation and gender identity from the range of reasons for requesting special protection.

In fact, in April the European Parliament drafted a Proposal for a Resolution in which it accuses Italy,

together with Poland and Hungary, of carrying out anti-LGBTQIA+ rhetoric and which states that the Parliament «expresses concern for the current anti-rights, anti-gender and anti-LGBTQIA+ rhetorical movements at a global level, fueled by some political and religious leaders around the world, including in the EU" and that "such movements [...] legitimize the rhetoric according to which LGBTQIA+ people are an ideology rather than human beings."

In the wake of this legal oblivion, it seems necessary to underline that many of these people who decide (or are forced) to migrate suffer a **series of violences** perpetuated over time in their country of origin. We mean **socio-cultural discrimination** when you are stigmatized by your family, your community and marginalized due to belonging to the LGBTQIA+ community; we mean **systemic violence** when even the State (citizens, law enforcement and paramilitary forces) in which the person is born and raised violates their fundamental rights through persecution, in-the-name-of-honour killings or death sentence; we also mean **psychological and**/ or physical (sometimes even sexual) violence, perpetrated by each of these social actors.

The consequences of this **vulnerability** can be multiple: most likely, the person may try to hide their orientation or gender identity to avoid repercussions; they could also develop internalized homophobia or transphobia, rejecting this component of their own identity: the person could therefore come to hate themselves and have actual suicidal thoughts; finally, a consequence could be that the person decides or is forced to abandon their country to look for a place where they can be themselves freely.

As it is easy to imagine, the situation of LGBT-QIA+ migrant people arriving in Italy is very delicate: they often find themselves victims of **double** stigmatization and are therefore discriminated against both as migrants and as LGBTQIA+ people. It is very likely that they avoid coming into contact with other migrant people coming from the same country, or that they are explicitly shunned by them: therefore the support network that usually helps a person socialise and find information is completely absent, with no chance of ant real support in their process of integration to the host country. For example, they may struggle more to find housing and a job. Furthermore, in the context of reception centres, they will be afraid that their orientation or identity will be revealed to other guests and that this will lead to the perpetuation of the discrimination already suffered.

For their complexity to emerge, each of these stories would need a space in which to be told, each of these people would need to see their voice amplified and listened to; although international legislation has taken a step in the right direction, the path towards true respect of human rights is still very long and this is why Torino Pride, after having focused on this 2022 AGM, intends to develop practices and actions towards the countries of North Africa and the Middle East. 







# INCLUSIVE HEALTHCARE

All the associations in Torino Pride have been dealing for years with many requests from migrant people, and saved many lives. GBTQIA+ people generally have the same health needs as the heterosexual and cisgender population, but **exposure** (often still on a daily basis due to the persistence of homobitransnegative stereotypes, prejudices and discrimination across all areas of society) **to experiences of stigmatisation**, harassment and social inequalities, re**quires that health care professions providers pay specific attention to the health care needs of these people**.

Access to and the use of health care services - as well as the use availability of resources that are crucial in terms of health such as family and friends support, school, housing and work - is often disadvantaged difficult for LGBTQIA+ people with im**portant negative effects** on their mental and/or physical health. Although it has been shown that belonging to the LGBTQIA+ population is not in itself indicative of psychopathology, the Minority Stress theory explains that individuals belonging to minorities, including those linked to sexual orientation and gender identity, **are exposed to greater** risks of psychological distress compared to the hetero and cis population precisely due to social stress linked to prejudice and stigma. Furthermore, various barriers persist in accessing healthcare services which can result in lead to the distancing of LGBTQIA+ people not going to get the care they need, but it can also have from services, but also have a negative impact on prevention and promotion of well-being and treatment practices. In fact, due to real or perceived homobitransnegativity, this segment of the population delays or avoids access to healthcare services (or turns away they simply do not go back after the their first access to care), omits information to medical personnel, denies consent to procedures, is not intercepted by screening programs, does not access fertility preservation services, relies on do-it-yourself medicine and adopts self-harming behaviors that predispose them to the development of chronic pathologies (such as abuse of food, tobacco, alcohol and substances drugs abuse) more frequently than to the hetero and cis population.

It is therefore urgent **that healthcare personnel are trained to adequately take care of LGBTQIA+ people** in order to provide inclusive, fair, non-discriminatory services capable of intercepting and truly responding to the specific healthcare needs of this segment of the population.

# SPEECH BY ALESSIA CROCINI (PRESIDENT OF FAMIGLIE ARCOBALENO)



Human Rights Conference Thessaloniki, June 28<sup>th</sup>, 2024



ood morning, my name is Alessia Crocini, Presi $oldsymbol{O}$  dent of Famiglie Arcobaleno, the Italian association that has been fighting for the rights of same-sex couples, LGBTQIA+ parents and their children since 2005. I would like to thank Thessaloniki Pride and Torino Pride, a candidate for EuroPride 2027, for the invitation and the opportunity to talk about the situation of Rainbow Families in Italy.

Italy is the only founding member state of the European Union and the only country in Western Europe to neither recognise equal marriage, the right to adoption for single parents and same-sex couples, nor recognition at birth for children with two mothers or two fathers.

Italy is one of the few European countries not to allow single women and female couples access to medically assisted procreation techniques.

Italy is perhaps the first European country to pass a law making it a universal crime to carry out pregnancy for others, even if done abroad in countries where it is legal.

A new bill by Fratelli d'Italia, the party of Premier Giorgia Meloni, is currently on its way to the Italian Senate, which wants to criminalise surrogacy with fines of up to one million euro and penalties of up to two years in prison.

Moreover, the Lega party of deputy prime minister Matteo Salvini has proposed an increase in fines to  $\in 2$  million and imprisonment of up to 10 years.

The bill's petitioner, Carolina Varchi, stated a few days ago that she and her party Fratelli d'Italia are committed to stop and cancel any advancement of rights for LGBTQIA+ people.

Only three months after Italy's Meloni government took office, its Home Affairs Minister Piantedosi sent a letter to Prefectures to force mayors to stop issuing birth certificates with two mothers or two fathers. As a result of this action, the Padua Public Prosecutor's Office appealed against more than 45 birth certificates of children with two mothers to cancel one of the two.

All over Italy we are witnessing a gradual demolition of every effort that had tried to safeguard the rights of children with LGBTQIA+ parents in the lack of a national law.

Meloni Government has now declared war on LGBTQIA+ families and trans people with shameful actions unworthy of a civilised country.

Today in Italy, a child born to a couple of two mothers is legally recognised only by the mother who gives birth to the child, and if the child has two fathers, only by the biological father.

The only path open is stepchild adoption, which forces the non-recognised parent to adopt their own children before a Children's Court in a long, expensive and humiliating process.

We are forced as LGBTQIA+ mothers and fathers to have meetings with social workers and psychologists and to take our children to social services in order to have what is rightfully ours, the fact that we are the mothers and fathers of our children every day of their lives.

We are treated as criminals and are forced to spend our time in court to ensure that even the most basic rights of citizenship are granted to us.

The current Deputy Prime Minister Salvini, when he was Home Affairs Minister in 2019 (twenty nineteen), changed the law on children's identity cards by replacing the word 'Parents' with 'MOTHER and FATHER' with the only purpose of discriminating against families with two mothers and two fathers.

On my son's identity card, I am registered as 'father' and I travel around Europe with a document issued by my country with incorrect information.

We have already won two instances in court on this case, but the Home Affairs Minister is now pursuing us to the third instance in an attempt to win against logic, common sense and law: children with same-sex parents do exist in Italy and are entitled to an identity document that reflects the real structure of their families.

The Home Affairs Ministry is also fighting alongside the public prosecutor's office to clear one of the two mothers of the 45 children in Padua.

The lawyers of my association together with those of Rete Lenford have already secured a victory in the first instance and we are waiting for the sentence of the Court of Appeal in Venice.

The Italian Constitutional Court has ruled several times on the issue: stepchild adoption is not a solution, a Parliament law is needed to give children of same-sex couples the same rights as all other children and teenagers in Italy.

All we have in Italy at the moment is the law on civil unions approved by the Democratic Party in 2016 which does not include any child rights and does not grant the right to adoption.

As a result, our children have half the rights their peers have, since the government deprives them of one of their parents.

These children are deprived of their right to their inheritance, to health, to education, to serenity.

To inheritance, because wills are not legally valid to secure the entire inheritance of parents who are not legally recognised.

To education, because a parent who is not legally recognised cannot enrol his or her child into a school, he or she must have a proxy even for the most mundane of tasks such as accompanying or picking up a child to school. And he or she cannot actively participate in school life by becoming a class representative, for example.

To health, because the non-legal parent cannot: choose a paediatrician, take their child for a vaccine, sign up for life-saving treatments, take parental leave from work, take leave and benefits for children with disabilities.

Stepchild adoption is not good enough because it is a process that can last up to five years and in that window of time the parent can become ill and die without being able to guarantee the protection of the child's rights.

Birth certificates of children born through surrogacy We provide training for schools, companies, profesabroad are not registered, thus also denying Italian sional bodies and the public administration because we know how important it is to implement change in citizenship and forcing minors to live as foreigners in their own country. every area of society.

The same thing happens to the children of women who give birth abroad who are denied the transcription of their birth certificates by the Italian authorities.

In the last few days, two mothers, one Italian and the other American, have been condemned to pay 15,000 (fifteen thousand) euros in legal fees simply for having requested recognition of them both as mothers of their child. The child was born in Italy and has two mothers, but his American mother gave birth to him and therefore he has no right to Italian citizenship.

Even though the ECHR (European Court of Human Rights) has defined stepchild adoption as sufficient to guarantee the rights of children with same-sex parents, it is totally inadequate in the case of conflictual separations because in order to obtain adoption, the legal parent's authorisation is needed. We have couples of separated mothers who have not seen their children for years and even end up spending tens of thousands of euros in legal fees just to obtain a right of visit.

Because of this situation, my association, Famiglie Arcobaleno, has been working for social and legislative change in Italy for almost 20 years.

We organise conferences, the most recent one just a few months ago was an international conference on surrogacy and it hosted jurists, anthropologists, lawyers, testimonies of women who have carried out pregnancies for others, teenagers born through surrogacy.

Famiglie Arcobaleno funds pilot legal actions in the courts to obtain the rights that politics and parliament do not grant us.

We organise events to make our families visible to all Italian people: parties, talks, workshops for adults and children.

Precisely because politics continues to neglect our rights, we decided to write a bill together with Rete Lenford, an Italian association of lawyers and jurists who fight for LGBTQIA+ rights.

This law plans to extend to same-sex couples and single parents the rights that are currently exclusively granted to couples formed by a man and a woman, in particular:

- marriage
- adoption for singles and same-sex couples
- recognition of children at birth for same-sex couples
- medically assisted procreation also for single women and female couples.

Together with the Luca Coscioni Association for scientific Freedom we have written another bill for ethical surrogacy.

We are sure that changes in a country take place at different levels, the Italian society right now is far ahead of its politics, but an extreme right-wing homophobic, conservative and misogynist political party such as the one now governing Italy is likely to set the country back one hundred years.

The Italian LGBTQIA+ movement is going through a dark moment while we were convinced that the path of rights could only move forward.

They may slow us down but they will not stop us because we have survived Fascism, Nazism, homophobic laws, persecution, we have made the Resistance a way of life and we will conquer our rights by continuing to march united, even and especially if this happens at a European level.
