Dear EPOA community members,

It is my utmost honor and joy to present our bid to host EuroPride 2027 and welcome you to Vilnius, a vibrant and diverse city so close to my heart.

As a young gay man, I found myself and my community in Vilnius. In 1993 my partner and I, together with our close circle of friends found out that Lithuania decriminalized same-sex relationships and established Lithuanian Gay League. Over the past 30 years, our organization has grown and became one of the most stable and mature organizations within the civic sector in Lithuania and the Baltic States, uniting the local LGBTIQ+ communities striving for positive progress on LGBTIQ+ rights. Despite the support of diverse human rights and LGBTIQ+ rights organizations, civil society and businesses championing LGBTIQ+ rights in their everyday operations, the current social climate and lack of political will of the Lithuanian Parliament does not allow LGBTIQ+ individuals to fully enjoy their fundamental rights and freedoms in Lithuania.

On the other hand, the last three years mark significant cooperation with the Ministry of Justice, Ministry of Social Security and Labour, Vilnius City Municipality, and ombuds, inspiring further collective work on social inclusion, hate speech prevention, and raising the issue of inclusive education for LGBTIQ+ young people.

Despite collective efforts to pass gender-neutral civil unions, establish an administrative procedure for legal gender recognition and revoke the discriminative amendments to the Law on the Protection of Minors against the Detrimental Effect of Public Information, Lithuania still offers no protection to same-sex couples, requires trans persons to apply to courts to change their gender markers in their IDs and censors LGBTIQ+ identities.



I know that my community is tired of waiting. We have been patiently waiting for 32 years since the restoration of independence of Lithuania. Our lives are fragile, and everyone deserves to live in dignity and freedom today. We need to keep up hope, solidarity and an opportunity to host EuroPride 2027 in Vilnius is that extra push.

Due to its historic cosmopolitan nature Vilnius is refuge to persecuted LGBTIQ+ communities from Belarus and Russia. An opportunity to host EuroPride 2027 in Vilnius will provide us all with an opportunity to come together in solidarity, celebrate individual uniqueness within our diverse communities, and support Ukrainian, Belarussian, and Russian LGBTIQ+ communities.

Moreover, EuroPride would coincide with Lithuanian Presidency of the Council of the European Union in 2027. The slogan of our EuroPride 2027 bid *FREE TO BE (YOURSELF)* beautifully encapsulates the spirit of the EU LGBTIQ Equality Strategy motto: *Building a Union of Equality where you are free to be yourself.*

EuroPride is not just a festival, It's a movement.

LITHUANIA. CENTER OF THE DEVELOPMENT OF FREEDOM AND DEMOCRACY

Lithuania has long been recognized for its diverse ethnic and religious make-up. Historically, the country has been home to ethnic Lithuanians as well as significant communities of Poles, Jews, Belarusians, Russians, Tatars, Ukrainians, Roma and Karaites. The settlement of these various groups took place at different times, with some communities establishing themselves in Lithuania as early as the 14th century, while others arrived in later centuries.



The Grand Duchy of Lithuania became one of the largest states in Europe in the 14th century. During this period, Lithuanian rulers generally pursued policies that recognized the value of diversity and religious tolerance. They typically did not enforce cultural or linguistic assimilation of non-Lithuanian communities within their territory, allowing these groups to maintain their distinct identities.

The Grand Duchy reached its greatest territorial extent in the early 15th century, with lands extending from the Baltic Sea in the north to the Black Sea in the south. This vast realm encompassed a multitude of ethnic and religious groups, contributing to its multicultural character. The tradition of religious tolerance was particularly evident during the reign of Grand Duke Gediminas (1316-1341).

In 1323, Gediminas sent missives to prominent European cities, extending an invitation to merchants, artisans, and farmers to take up residence in Lithuania. In these missives, he pledged religious freedom and favorable economic conditions to those who would settle in his realm. This initiative not only contributed to the growth and diversification of the Grand Duchy but also facilitated the establishment of international connections.

The year 1323 is also of historical significance as it marks the first written mention of Vilnius, the capital of Lithuania, in the correspondence of Gediminas. Although evidence suggests that Vilnius existed as a settlement prior to this date, 1323 is often regarded as the official founding year of the city. Vilnius has continued to develop into a multiethnic metropolis, remaining one of the most diverse cities in Lithuania to this day, reflecting the country's historical legacy of cultural pluralism.

The policy of openness and tolerance established the basis for Lithuania's enduring tradition of diversity. Despite historical challenges and changes, this tradition continues to exert an influence on the country's social and cultural landscape in the present era.

Lithuania, as part of the Polish–Lithuanian Commonwealth, played a pivotal role in the development of constitutionalism in Europe. In 1791, it co-authored one of the earliest modern constitutions

in Europe, which represented a significant step towards modern constitutional monarchy and democracy in Europe.

The interwar period in Lithuania (1918-1940) was distinguished by notable cultural diversity and intricate social dynamics. While the country witnessed advancements in certain domains, such as the extension of suffrage to women, other aspects of social equality remained a subject of contention.

In 1918, Lithuania became one of the first countries in the region to grant women the right to vote, a move that was also embraced by its Baltic neighbors, Estonia (1918) and Latvia (1920). This was an earlier date than that at which many Western nations granted women the right to vote. These included the United States (1920), the Netherlands (1919), and France (1944). The early adoption of women's suffrage in Lithuania reflected the country's commitment to certain democratic principles as it established itself as a modern, independent nation. However, the situation for LGBTQI+ individuals during this period was considerably more challenging. Following the restoration of independence in 1918, information about LGBTQI+ people in Lithuania remains limited. During the interwar period in Lithuania, as in the previous Tsarist Russian period, male homosexuality was criminalized. This legal stance reflected broader societal attitudes and presented significant obstacles for LGBTQI+ individuals.

Notwithstanding the challenges, there were some notable LGBTQI+ figures within Lithuanian society during this period. One such individual was Vera Šleivytė, an openly lesbian artist born in 1906 in Antašava. Šleivytė was a painter, graphic artist, and photographer, and is regarded as a prominent LGBT+ figure from this era in Lithuania. Despite the persisting legal and societal barriers faced by the LGBTQI+ community, her contributions to the cultural landscape of Lithuania during the interwar period were significant.

This period also witnessed a flourishing of Lithuanian culture and intellectual life, with contributions from

various ethnic communities, including significant Jewish, Polish, and Russian populations. Cities like Vilnius served to exemplify the country's multicultural character.

The interwar period in Lithuania thus presents a complex picture. While there were progressive developments in some areas, such as the advancement of women's political rights, discriminatory laws and attitudes persisted in other domains, particularly with regard to LGBTQI+ individuals. This complexity reflects the broader challenges of nation-building and societal development in the early 20th century, where steps towards equality often coexisted with persistent forms of discrimination.

The period following the Second World War was one of significant loss and transformation for Lithuania, ultimately resulting in its incorporation into the Soviet Union through annexation and the imposition of forced integration. This period of upheaval commenced with the Soviet occupation in 1940, which followed the Molotov-Ribbentrop Pact. This was succeeded by Nazi German occupation from 1941 to 1944, after which the Soviet forces reoccupied the territory from 1944 to 1945. From 1944 to 1953, Lithuanian partisans engaged in armed resistance against Soviet rule. Throughout this period and beyond, Lithuania suffered significant population losses due to several factors, including war casualties, deportations to Siberia, the Holocaust, in which some Lithuanians took an active part, and emigration. By 1945, Lithuania was fully incorporated into the Soviet Union as the Lithuanian Soviet Socialist Republic, a status that endured until 1990. These events had a

profound impact on Lithuania's demographic, cultural, and political landscape, resulting in the loss of independence, the implementation of forced collectivization, attempts at russification and the suppression of national identity, and significant shifts in its ethnic composition.

In 1990, Lithuania made history by becoming the first Soviet-occupied republic to declare and restore its independence, marking a pivotal moment in the dissolution of the Soviet Union. This bold move on 11 March 1990 set off a chain reaction that would ultimately lead to the collapse of Soviet rule in Eastern Europe.

Notwithstanding the considerable progress made by Lithuania in the realms of political autonomy and democratic governance following its 1990 Declaration of Independence, certain social and legal reforms have remained relatively underdeveloped. A case in point is the continued application of the Soviet-era criminal code which criminalized male homosexuality until 1993. This legislation was not merely an anachronistic moral statute; it had been a

means of widespread oppression during the Soviet era. The legislation directly persecuted LGBTQI+ individuals and was frequently deployed against political dissidents and those who opposed the Soviet regime, irrespective of their sexual orientation. The law reinforced a culture of surveillance and mistrust, as it could be selectively enforced to target various elements of society deemed undesirable. The delayed repeal of this law reflects the complex challenges inherent in the process of dismantling the legal and social structures that were established during the Soviet era. This transition to democracy involves not only political reforms but also the painstaking process of re-evaluating deeply ingrained social attitudes and legal frameworks. This history underscores the intersectionality of human rights struggles in post-Soviet states, where the fight for LGBTQI+ rights often overlapped with broader movements for political freedom and human dignity.

The decriminalization of homosexuality in 1993 constituted a significant stride towards the advancement of LGBTQI+ rights in Lithuania, bringing the country into closer alignment with the human rights standards prevalent in Western Europe. Nevertheless, it is important to acknowledge that this legal reform did not immediately result in the full social acceptance or equality of LGBTQI+ individuals, a process that continues to evolve in Lithuania and numerous other post-Soviet countries.

This juxtaposition of rapid political change with slower social reform demonstrates the multifaceted challenges faced by newly independent states in the post-Soviet era as they attempted to rebuild their national identities and legal frameworks, a process which was inherently complex.

The restoration and consolidation of Lithuania's statehood was facilitated by the historical commitment of democratic Western countries to the principles of freedom, democracy, human rights and international law during the Cold War. The survival of these values at the center of Western world politics, and the further development of a free and indivisible Europe, is a necessary condition for Lithuania's security and prosperity.

The process of Lithuania's integration into international and EU mechanisms commenced shortly

after the country's independence was reaffirmed in 1990. In 1991, the country became a member of the United Nations, and in 1993, joined the Council of Europe. The year 2004 was a pivotal one for Lithuania, as it became a member of both the North Atlantic Treaty Organization (NATO) and the European Union (EU), thereby solidifying its alignment with Western institutions. Subsequently, Lithuania became a member of the Schengen Area in 2007, thereby enabling the free movement of people within most of the member states of the EU. The adoption of the euro by Lithuania in 2015 represented a significant step in the country's economic integration, marking its entry into the Eurozone as the 19th member state. Additionally, in 2001 the country became a member of the World Trade Organization, and in 2018 it joined the Organization for Economic Co-operation and Development (OECD). Other notable memberships include the Organization for Security and Cooperation in Europe (OSCE) since 1991 and the Council of the Baltic Sea States, which it helped found in 1992. These integrations necessitated extensive reforms across a range of societal sectors, reflecting the country's dedication to democratic principles, a

market economy, and international collaboration.

The preceding decade has demonstrated in a stark manner that the tenets of democracy, the rule of law, and human rights are not guaranteed, but rather require constant vigilance. In contrast with the expectations that had been formed earlier, the countries that border the European Union have not demonstrated a consistent alignment with the principles of the EU, thereby underscoring the intricate challenges inherent in the post-Soviet transformation process. Concurrently, the EU is confronted with considerable challenges to its democratic foundations, including the ascendance of far-right, anti-gender, and anti-human rights movements, restrictions on the right to peaceful assembly, and the persistence of hate speech and violence directed at LGBTQI+ individuals. These issues are not exclusive to the newer EU members and reflect global trends of democratic regression and the resurgence of illiberal ideologies. These developments highlight the ongoing tensions between traditional values and evolving social norms, particularly regarding gender equality and LGBTI+ rights. They serve as a stark reminder that democratic

progress is neither linear nor irreversible, and that there is a need for renewed commitment to core European values, stronger enforcement mechanisms within the EU, and more effective strategies to counter disinformation and hate speech. The EU's response to these challenges will be crucial in shaping the future of European democracy and human rights.

During the recent European Parliament elections far-right parties won about 40% of seats. This is a dramatic increase in comparison to the last five years, when only 25% of members of the European Parliament voted against the rights of LGBTIQ+ people. The international anti-LGBTIQ+ movement is more organized than ever before. Through infiltration and disinformation, these anti-LGBTIQ+ associations and accomplices seek to not only withhold our rights but topple our democratically elected governments. Our rights are attacked everywhere. That's why we need to work collectively at the international level, exposing the anti-democratic forces that are scapegoating LGBTIQ+ communities across the world. In this complicated geopolitical context, Lithuania:

- Stands in support for freedom fighters around the world. Lithuania strives to help all those defending their freedoms and rights, from the fighters for a free Belarus to people and states defending their fundamental rights all over the world, regardless of their geographical location.
- Strives for free Belarus. Our aid to civil society and democratic Belarus remains strong and diverse solidarity instruments allow us to hope for free, democratic and legal elections in Belarus.
- Contributes to freedom and democracy agenda in the European Union. Lithuania aims that the space of the fundamental values of the European Union

 democracy, the rule of law and human rights
 does not shrink but expands both outside the European Union and within it.
- Aims to create broader coalitions of like-minded democratic states, transatlantic or international alliances, to help the Belarusians' struggle for freedom and democracy, as well as to consolidate

the perspectives of Moldova's, Sakartvelo, Ukraine's membership in the European Union ahead the Lithuanian Presidency of the Council of the European Union in 2027.


 Takes a principled stance in the face of Russian aggression. We support targeted and economic sanctions against the Russian regime; efforts of Moldova, Sakartvelo, Ukraine and other states in the region to become members of the European Union and NATO and help Sakartvelo and Ukraine seek to recover the territories occupied and annexed by Russia.

Despite these positive actions in safeguarding fundamental freedoms and democracy, there has been little to no progress on LGBTIQ+ human rights since Lithuania's accession to the European Union in 2004. Lithuania ranks 34th out of 49 countries ranked in the Rainbow Map.

Lithuania:

Offers no legal recognition of same-sex
relationships.

- Censors LGBTIQ+ identities as still existing antigay propaganda provision contributes to limiting LGBTIQ+ expression and visibility.
- Does not offer adequate investigation and prosecution of anti-LGBTIQ+ hate crimes.
- Does not offer sufficient access to trans-specific healthcare.
- Provides no administrative procedure for legal gender recognition.



While institutional measures addressing LGBTIQ+ rights remain inadequate and lack a comprehensive strategy, some incremental progress deserves recognition. Two notable developments mark small but significant steps forward:

- The government's Equal Opportunities Action Plan for 2024-2026 includes, for the first time, a targeted LGBTIQ-specific measure with allocated funding.
- 2. In 2023, the Seimas Ombudsperson Office, in collaboration with LGL, organized an unprecedented inter-sectoral discussion on a national LGBTIQ+ action plan, bringing together representatives from all relevant ministries.

- **3.** Ministry of Justice took steps to repeal the anti-gay propaganda provision in 2024.
- 4. In 2019, the Constitutional Court made a significant ruling in favor of recognizing same-sex unions concluded abroad, specifically within the context of EU free movement and family reunification regulations. This decision marked a notable step towards acknowledging the rights of same-sex couples, at least in limited circumstances related to EU law.

These initiatives, though limited in scope, signal a growing willingness to engage with LGBTIQ+ issues at the institutional level and lay groundwork for potential future improvements.

An opportunity to host the EuroPride 2027 in Vilnius will provide a powerful impetus in our strive to advance in LGBTIQ+ human rights and allow diverse Lithuanian LGBTIQ+ community, Belarussian, Ukrainian, and Russian LGBTIQ+ communities who found refuge in Lithuania, to come together in solidarity in our journey towards enjoyment of fundamental freedoms and democracy. Here's how.

We believe the concept proposed for EuroPride 2027 Vilnius beautifully captures the spirit of celebrating individual uniqueness within our diverse community. The slogan FREE TO BE (YOURSELF) perfectly encapsulates this spirit and aligns with the EU LGBTIQ Equality Strategy motto: *Building a Union of Equality where you are free to be yourself.*

This is particularly significant as **EuroPride will coincide with** Lithuanian Presidency of the Council of the European Union in 2027, highlighting the importance of LGBTIQ+ rights on both national and European levels.

Hosting EuroPride would spotlight Vilnius as a beacon of inclusivity for LGBTIQ+ visitors from across Europe and beyond. The city has already proven its ability to organize major international events, as demonstrated by the successful NATO Summit and recordbreaking Lithuanian Pride celebrations. These achievements underscore Vilnius readiness to host EuroPride, an event that would further solidify its standing as an open, progressive European capital. Moreover, this opportunity would create a powerful impetus for Lithuania to deepen its commitment to equality, potentially spurring positive social and legislative changes nationwide.

While Lithuania has made strides in recent years, the LGBTIQ+ community still faces significant challenges. EuroPride 2027 presents a unique opportunity to address these issues and accelerate progress towards equality and inclusion.

CURRENT CHALLENGES:

LEGAL RECOGNITION AND PROTECTION:

- Lack of legal recognition for same-sex partnerships
- Barriers for transgender individuals in certain occupations
- No administrative procedure for legal gender recognition
- Ongoing anti-gay propaganda provision

- Restricted access to PrEP medication

- Negative public attitudes influenced by conservative social norms

4. SAFETY AND DISCRIMINATION:

- Risk of hate crimes and hate speech
- Workplace discrimination affecting career opportunities
- Conversion therapies not yet banned

5. SUPPORT SERVICES:

- Shortage of targeted support services, particularly in mental and sexual health
- No targeted measures to assist LGBTIQ+ hate crime victims
- Limited assistance for victims of crime (only 10.3% of registered victims received help in Q4 2021 H1 2023)

9. CULTURAL SHIFT: By celebrating LGBTIQ+ identities on a large scale, EuroPride can challenge traditional narratives and contribute to a more inclusive cultural landscape. EuroPride 2027 in Lithuania represents more than just a celebration; it's a catalyst for change. The European Court of Human Rights issued a judgment in the case of Beizaras and Levickas v. Lithuania. As a result, pre-trial investigations of hate crimes against LGBTIQ+ persons have been initiated or reopened.


The ruling of the Constitutional Court of the Republic of Lithuania recognized the right of the same-sex spouse or partner of a Lithuanian citizen to obtain a residence permit in Lithuania based on family reunification.

Baltic Pride attracted 10,000 participants under the slogan "We are Family".

2021

The first Kaunas Pride march, organized by the May 1st Labour Union, was attended by approximately 2000 individuals. The event was heavily policed, with the city's main street cordoned off by fences. During the event, 22 individuals were arrested for violating public order or inciting hatred. Vilnius hosted the fifth Baltic Pride festival, organized by LGL in cooperation with the municipalities of Vilnius and Oslo. The largest ever private and public sector support was consolidated, and around 15 000 people took part in the march. The Lithuanian government has petitioned the Constitutional Court to determine whether the lack of legal recognition for same-sex partnerships violates the country's Constitution.

Lithuanian Pride march and celebration organized by LGL set a record, drawing approximately 17,000 participants—the largest turnout for any Pride event in the country's history. The festivities culminated in Vilnius's sprawling Vingis Park, which hosted the most expansive Pride stage and concert ever seen in the Baltic states.

The EuroPride 2027 Vilnius bid represents a joint effort by LGBTIQ+ rights organizations, civil society, local authorities and independent participants.

Governance

Founded in 1993, the National LGBTIQ+ rights organization **Lithuanian Gay League** (LGL) is the country's oldest LGBTIQ+ rights organization. The main principle that characterizes the activities of the association is that of independence from any political or financial interests, with the aim of attaining effective social inclusion and integration of the local LGBTIQ+ community in Lithuania. Based on its expertise in the fields of advocacy, awareness raising and community building, accumulated during thirty years of organizational existence, LGL strives for the consistent progress in the field of human rights for LGBTIQ+ people.

LGL organized the first Pride event in 2010. Since then, Baltic Pride events took place in Vilnius in 2013, 2016, 2019, 2022 and will take place in 2025. In 2024 LGL started to host annual Pride events, with the first Lithuanian Pride event attracting 15000 participants. In 2026 LGL will also organize the Lithuanian Pride.

LGL's team is composed of 5 Board members, 5 staff members, and more than 20 local and international volunteers. Our team is vibrant, dynamic, energetic and always open for new members, ideas and projects. It must be emphasized that not only LGBTIQ+ individuals participate in the activities of the organization. Together with the members of the local LGBTIQ+ community, we are proud of our friends and supporters, who first and foremost associate LGBTIQ+ rights with the issues of democratic governance and effective human rights protection for all the citizens of the Republic of Lithuania without any exceptions.

The office of the association LGL is in Vilnius, Odminių str. 11-4. This is the space where the LGL team is implementing various projects, organizing meetings and constantly inviting members of the local LGBTIQ+ community and their supporters to attend various events. The LGL office is also the home for the sole LGBTIQ+ center in the country. The Center hosts a library in relation to the organization's activities, free internet access is provided, and people are always welcome to come by for a cup of coffee or tea. The LGBTIQ+ center is open for all well-meaning visitors who are willing to know more about the activities of the organization and about the situation of LGBTIQ+ human rights in Lithuania.

LGL is a member the Human Rights Coalition. LGL also takes part in international cooperation within the framework of international umbrella organizations such as:

ILGA (International Gay and Lesbian Association, IGLYO (the International Lesbian, Gay, Bisexual, Transgender, Queer Youth and Student Organization), EPOA (The European Pride Organizers Association), European Pride Business Network (EPBN), Fundamental Rights Agency Civic Society and Fundamental Rights Platform (FRA), TGEU (The European Transgender Network), International Network Against Cyber Hate (INACH), ANSO (Association of Nordic and Pol-Balt LGBTQ Student Organizations) and international volunteering network Volunteurope.

We believe that our strategic objectives can be achieved only through positioning the LGBTIQ+ rights question within the broader discourse on human rights, therefore we actively support various initiatives both on national and international levels.



CIVIL SOCIETY ADVISORY COUNCIL

The Civil Society Advisory Council has a two-fold role to:

1. Consult on the perspective of individual groups within the local LGBTIQ+ communities, so that EuroPride would reflect the diversity of our community.

2. Consult on the community building, so that EuroPride would involve different groups within the local LGBTIQ+ communities and different cities.



INTERNATIONAL HUMAN RIGHTS CONFERENCE

EuroPride will include a three-day international conference focused on different topics: LBT women's rights, Lithuanian Presidency of the Council of the European Union, hate crimes against LGBTIQ+ people, workplace diversity, LGBTIQ+ inclusive education and more.

Pre-conference on LBT women's rights

The international human rights conference will kick-off with a preconference event specifically focused on the issues faced by LBT women. LBT women face additional challenges and worries not only because of their gender, but also because of who they are and whom they love. The challenges include higher rates of physical and emotional violence in multiple areas of their lives, harassment, discrimination, lack of institutional support. Cultivating community and resilience is essential in ensuring the rights of LBT women. The pre-conference will explore how self-determination, community and freedom to choose who they want to be with can positively impact wellbeing of LBT women. The pre-conference will be organized in cooperation with EuroCentralAsian Lesbian Community (EL*C).

HUMAN RIGHTS CONFERENCE (DAY 1)

HUMAN RIGHTS CONFERENCE (DAY 2)

The first day of the conference will be dedicated to EU LGBTIQ Equality Strategy 2026-2030 and the need for Lithuanian LGBTIQ+ action plan. The event will showcase the good practices available in different countries and explore how a good LGBTIQ+ action plan can positively affect the daily lives of LGBTIQ+ people. Keynote speeches, panel discussions and closing addresses will be focused on various areas of activities indicated in LGBTIQ+ action plan and reflect on the impact and shortcomings of EU LGBTIQ Equality Strategy 2026-2030. The conference will be organized in cooperation with the Lithuanian Presidency of the Council of the European Union. The final day of the conference will explore the most pressing issues faced by the local LGBTIQ+ community and provide a space for Belarussian and Russian LGBTIQ+ communities who found refuge in Lithuania. The conference will explore the current situation of hate speech and hate crimes against LGBTIQ+ community, good practices of workplace diversity, and the situation of LGBTIQ+ students in their educational settings. A wide range of topics will be discussed during keynote speeches, panel discussions and closing addresses, and a specific panel discussion will be dedicated to the needs of the local Belarussian and Russian LGBTIQ+ communities facing persecution their home countries. The final day of the conference will be organized in cooperation with European Pride Business Network (EPBN).

EUROPRIDE MARCH, CLOSING CEREMONY & CONCERT

The EuroPride March will take you on a most scenic route which will stretch for 4,3 km. The March will start next to Bernardine Gardens (Barboros Radvilaitės Street), continue at Gediminas avenue and finish at Vingis park where a grand concert and closing ceremony will take place.

The march will be the biggest human rights event in Lithuanian history, uniting LGBTIQ+ communities, civil society, LGBTIQ+ friendly businesses and allies. Up to 20 musical trucks will enliven the march and amplify its message, allowing elderly people, persons with disability, families with children to participate at the Pride without barriers.

Up to 40000 people will march in support for LGBTIQ+ human rights, urging for legal recognition and protection, healthcare access, elimination of social and cultural barriers, safety from discrimination and LGBTIQ+ inclusive support services. The slogan FREE TO BE (YOURSELF) will celebrate individual uniqueness within our diverse community. The march will create a powerful impetus for Lithuania to deepen its commitment to equality, potentially spurring positive social and legislative changes. The march will conclude with a grand concert in Vingis Park on the biggest LGBTIQ+ stage in the Baltic States. Local and international pop stars, drag divas and Eurovision contestants will perform at the concert. The concert will conclude with the official closing ceremony. The concert will be organized in cooperation with M.A.M.A. Music Awards.

THE CULTURAL AGENDA

The EuroPride will present a variety of cultural events and coincide with Culture night Vilnius.

The Queer Art Exhibition will be opened at Mo Museum during the conference. The exhibition will showcase the history of the Baltic Pride in Vilnius and will be open for visitors throughout the summer.

The Drag Opera will provide a space for LGBTIQ+ stories and showcase the best drag performances. The local and international performers will perform live and guarantee a spectacular and unique event. The Film Night will be focused on European queer cinema and will take place under the stars at the EuroPride Village.

The EuroPride Village will also provide space for grassroot community cultural events, with a special focus on LGBTIQ+ youth.

The official opening ceremony, concert by community artists and award ceremony will take place on the stage next to the EuroPride Village.





COMMUNITY SAFE SPACE

The EuroPride will provide a safe space for the local LGBTIQ+ communities to meet, self-organize and host workshops and discussions at the EuroPride Village.

The EuroPride Village will be situated in the heart of Vilnius next to the City Hall, ensuring a welcoming atmosphere and spontaneity. The EuroPride Village will be open for 7 days and serve as an info-point. The activities will take place in a big tent, allowing shelter from noise and rain.

The EuroPride Village will have a special focus on the issues faced by LGBTIQ+ youth and other underprivileged groups within the LGBTIQ+ community and provide space for self-organizing and private initiatives.

A social brunch will take place on Sunday after the Pride event at Paviljonas bar and will be open to all participants of the Pride, allowing for networking, sharing and community building.







FREEDOM TO BE (YOURSELF)

The main EuroPride events will take place on Saturday-Sunday 5-13 June 2027, which coincides with Lithuanian Presidency of the Council of the European Union and Culture night Vilnius, attracting locals and tourists to enjoy culture in Vilnius.

The EuroPride Village will open on Saturday 5 June 2027 and will be open for 7 days providing a safe space for community building, networking, grassroot cultural and community events.

On Monday 7 June 2027 Queer Art Exhibition will be opened at the Mo Museum, showcasing the history of Pride in Lithuania and remain open for visitors for the remainder of the summer.

On Wednesday 9 June 2027 the international human rights conference will be opened with a preconference on the rights of LBT women. On Thursday the conference will continue with a focus on EU LGBTIQ Equality Strategy 2026-2030 and the need for Lithuanian LGBTIQ+ action plan. The conference will conclude on Friday and cover a variety of topics, such as current situation of hate speech and hate crimes against LGBTIQ+ community, good practices

of workplace diversity, and the situation of LGBTIQ+ students in their educational settings. The conference will also provide a space for Belarussian and Russian LGBTIQ+ communities who found refuge in Lithuania.

On Saturday 12 June 2027 EuroPride will conclude with the March, closing ceremony & concert, taking you closer to FREEDOM TO BE (YOURSELF), celebrating individual uniqueness within our diverse community, and creating a powerful impetus for Lithuania to deepen its commitment to equality, potentially spurring positive social and legislative changes.


Arrival & Getting Around

Vilnius International Airport operates direct flights to Europe's main cities, with flight times of only three hours or less. And with new routes and operators being introduced throughout the year, the city's global reach is set to expand. The airport, meanwhile, is only a 15-minute taxi ride from the center.

Currently, more than 15 airlines offer direct flights to more than 40 destinations from Vilnius International Airport. The city also boasts plentiful bus and ferry links from neighbouring countries.

Lithuania's rail network is the perfect way to explore the country and beyond. With convenient links to most of the country's cities, rail is a comfortable and affordable way to see some of the best that Lithuania has to offer.

Vilnius is perfectly sized for getting around. Even if you stay at apartments on the outskirts, the center is only a short 30-minute commute at most. The city also boasts a modern and integrated public transportation infrastructure, and you'll find that there are trolley buses and buses connecting every corner of the city.



Costs

Lithuania is a good value-for-money destination, offering attractive prices for highend accommodation, where a 4**** hotel stay may cost as low as 70 Eur/ person. Restaurants in the capital offer different options, from street food up to 5 Eur to average dinners that rarely exceed EUR 50/person. 
