# **WORKSHOPS SESSION 1**

# 1. Building Legacy through WorldPride: How could WorldPride be a driving force for social change? (Pedro Almodóvar's Room)

Pride Barcelona is bidding to host WorldPride in 2030 with a clear message and propose, build community and show to the world as a resistance through activism, protest, visibility and celebration. However, nowadays there are some political challenges we face, and we want to make sure we are going above those attacks to our community and to human rights in general.

In this workshop, we want to explore and reflect about the transformative potential of WorldPride. Pride Barcelona's DNA built with an active social movement full of protest and reivindication. That's why we want to explore together about how a massive LGBTQIA+ event can move the world in a colorful and diverse direction.

# 2: Pride Rising: Understanding and Celebrating LGBTQIA+ History in South Asia (La Veneno's Room)

This workshop aims to educate, inspire, and empower participants by exploring the unique history, challenges, and achievements of South Asian pride movements. It is designed for international community activists, pride organisers, educators, and stakeholders with an interest in diversity and inclusion.

The session will cover key historical milestones in South Asian LGBTQIA+ movements, including landmark legal changes such as the decriminalisation of homosexuality in India and Nepal, major Pride events, and significant court cases. It will also address intersectionality, examining how queerness intersects with class, caste, religion, and gender in South Asian societies. Participants will be introduced to rich cultural representations of queerness through myths, art, mythology, and indigenous gender identities such as hijra, kothi, and meti.

Contemporary challenges will be discussed, including rights, social acceptance, activism, and visibility, alongside case studies from India, Pakistan, Nepal, Bangladesh, and Sri Lanka that highlight both successes and ongoing barriers to reform.

## **WORKSHOPS SESSION 1**

The workshop will combine presentation, storytelling, interactive activities, and Q&A. Depending on the duration, activities may include an LGBTQIA+ timeline exercise, story circles, a map-unmap activity, and a Pride-themed scavenger hunt, ensuring participants engage both intellectually and creatively.

#### 3: Ukrainian Prides during wartime: challenges and gains (Margarida Xirgu's Room)

Almost four years have passed since Russia launched a full-scale invasion of Ukraine. During this period, we have had time to experience shock, recover from it, work under stress, work under constant stress, try to unite with right-wing radicals, rally with LGBTQI+ military personnel, and continue to work as if pride in wartime is something we have been doing all our lives. What we couldn't do was truly accept the war as a given and stop fighting as if it would never end. At the workshop, we will try to view our experience through the eyes of our European colleagues. We will try to talk about our prides as if you asked us, 'What if war comes to our homes, what should we expect? How should we act?' We may complain a little, but for the most part, we will try to highlight the lessons we have learned.

# 4: Pride, Protest, and Profit: Navigating the Backlash and Division Within the LGBT Movement (Margarida Xirgu's Room)

Questions are emerging about who funds Pride - and at what cost.

This session will explore how Pride organizations are working to avoid pinkwashing, balancing competing pressures with the goal of remaining independent. Panelists will discuss current challenges and opportunities, including recent global mobilizations that have sparked protests and intense internal debates, creating divisions within the movement. They will also examine lessons to be learned from alternative funding models already tested across Europe.

#### 5: Splitting up or growing? "Main" vs independent pride (Margarida Xirgu's Room)

This session explores the presence of both large-scale Pride events and smaller, independent Prides and community initiatives within the same city. Together, we'll consider what impact this has on the local community: do these celebrations strengthen connections, or do they sometimes create divisions? Participants will share their experience on how to work together, and not against each other. Let's discuss if corporate and grassroots events can compliment each other and how to ensure that LGBTQ+ rights remain at the centre of our events.

#### 7: Sex and gender education (room at the ground floor)

We believe that sex-affective and gender diversity education is an unresolved issue that we must continue to advocate for. However, despite regulations requiring it, there is a visible lack of education today, as seen through bullying and harassment against LGTBIQ+ individuals in various settings. Is LGTBIQ-phobia the norm in classrooms? Are we witnessing generational changes? When and how should sex-affective and gender diversity be taught in educational institutions? Who are the key players involved? LGTBIQ-phobia and bullying in schools are just the tip of an iceberg that needs to be addressed at its root.
